Direct Services: The organization provided 21,516 direct service hours of business and development services to our supported organizations. These services include integrated expertise in accounting and fiscal management, database management and administrative support, fund development support, board and strategy development and human resources support. These services build capacity, create back office efficiency, and provide tools and expertise that allow supported organizations to focus their time and resources on achieving their stated mission. One hundred sixty three (163) nonprofit 501(c)(3) agencies were served. In 2020, our organization helped client organizations navigate COVID related issues such as PPP loan application and forgiveness assistance and navigation of other resources available to support non-profits in a time of uncertainty and limited capacity.

Education: In 2020 the organization focused its education programming toward organizational support through direct resources and communication which included: Newsletter and direct email communications were sent to contacts educating them on topics relevant to current events. Each communication provided information to help organizations build capacity and provided links to SKC team members who could provide additional support as needed. SKC staff met with over 65 agencies one-on-one to provide guidance and resources as they explored ways to build their organizational capacity. SKC provided direct service to select organizations to build capacity for child care centers in connection with a capacity building grant awarded to SKC.

Community Impact: Initiatives that seek to enhance nonprofit sector skills, organizational effectiveness, and engagement of stakeholders in our community in 2020 included SKC providing resources for; The organization acted as the fiscal sponsor and backbone service organization for the Cultural Competency Collective of GKC and in 2020 successfully transitioned the collective to a new oversight organization that will support continued growth and sustainability for the Collective SKC acts as the fiscal agent for certain grant awards through the Health Forward Foundation. As part of our fiscal agent work SKC provides organizational assessments for grantees and provides education to the organization and their boards on best practices in the areas of financial management and governance. Board Diversity and Inclusion - SKC is working to create a board training program to coach boards on recruiting and retaining diverse board members, and preparing individuals for board service.
